This firm represents the interests of Veranda Partners, LLC. Veranda Partners, LLC ("VP") is a real estate developer who is currently developing the mixed-use urban town center named "Veranda Park" in the heart of MetroWest. VP has established goodwill and a positive and trustworthy reputation with customers and potential customers regarding the Veranda Park project. This goodwill and reputation are significant assets to VP as they help separate VP from other developers and real estate development projects ongoing in the MetroWest community.

It has come to our attention that you are currently publishing a website located at the domain name "www.verandaparknews.com" ("Website"). Your Website is a campaign designed to disparage and injure VP's reputation and goodwill and is intended to interfere with VP's contractual relationships with its customers and potential customers. Your Website contains numerous false and malicious statements attributing conduct and characteristics to VP that are contrary to customary and lawful real estate development business practices. Your Website has tarnished VP's goodwill and reputation by subjecting VP to distrust, ridicule, contempt, and disgrace. The false and malicious statements made on your Website have caused VP to suffer business harm and loss due to the Website's interference with VP's contractual relationships with its customers and potential customers.



Your Website also clearly fails to abide by the Acceptable Use Policy promulgated by your web host provider. The Acceptable Use Policy provides that you are prohibited from publishing content on your Website that is (a) harassing to another, or encourages harassing behavior, and (b) a violation of the law. Thus, your actions also constitute a violation of your web host provider's Acceptable Use Policy and may subject you to further penalties and damages imposed by your web host provider. Please be advised that we are also in communication with your web host provider to immediately shutdown the Website due to your unlawful activity.

VP is outraged that you would intentionally interfere with their business practices and actively engage in publishing false and malicious statements designed to injure its reputation. VP intends to immediately file a lawsuit against you for substantial monetary damages and injunctive relief to shutdown your Website. This letter is intended to serve as your *sole* opportunity to avoid litigation.

Accordingly, you have until **11:59 p.m. tomorrow, Saturday February 24, 2007**, to immediately discontinue and shutdown the Website. VP will file the above-referenced lawsuit against you on Monday February 26, 2007 if you fail to comply with the foregoing demand without any further communication with or notice to you.
